Measurement Rule

- 1. Annual cards may be purchased for \$5.00. Members are not required to purchase an annual card.
2. The owner of every pony or miniature horse/mule/donkey shall have either an annual PtHA® measurement certificate, a permanent PtHA measurement certificate issued prior to 12/31/21, or be measured at the show. There is no charge for the at show measurement.
3. Annual measurement certificates are valid from January 1st, or date of issue, to December 31st of the current year.
4. All Pintos are to be measured at the highest point of the withers, standing square.

- Miniature Horse - 35" and under
Miniature "B" Horse - over 35", not exceeding 39"
Miniature Donkey - 34" and under
Miniature "B" Donkey - over 34", not exceeding 38"
Miniature Mule/Hinny - 38" and under
Miniature "B" Mule/Hinny - over 38", not exceeding 50"
Pony A - over 39", not exceeding 43"
Pony B - over 43", not exceeding 50"
Pony C - over 50", not exceeding 56"
Small Standard Donkey - over 38", not exceeding 40"
Standard Donkey - over 40", not exceeding 48"
Large Standard Donkey - over 48", not exceeding 54"
